► It is understood and agreed that Blue Water Boat Centers, Inc. d/b/a Blue Water Boat Brokers has non-exclusive sales rights for the above named vessel. I herewith agree to Blue Water Boat Centers, Inc. d/b/a Blue Water Boat Brokers immediately upon acceptance of any offer through another individual or brokerage firm.

► In the case of a sale or exchange made within one hundred-twenty (120) days after the termination of this listing agreement to parties with whom Blue Water Boat Centers, Inc. d/b/a Blue Water Boat Brokers negotiated, or showed the above name vessel to, during the life of the agreement, I agree to pay Blue Water Boat Centers, Inc. d/b/a Blue Water Boat Brokers a full commission of ten percent (10%) of the gross sale price (\$5,000.00 on lesser transactions). In case a deposit is forfeited, one half shall be deemed payable to Blue Water Boat Centers, Inc. d/b/a Blue Water Boat Brokers and one half shall be payable to the Seller.
